25 1. This matter may be placed on the Hearing Board of the South Coast AQMD’s (“Hearing
26 Board”) Consent Calendar for Wednesday, September 11, 2024.

27 2. The Declaration of Angela Robertson and the Declaration of Jennifer Mulkern are submitted
28 to the Hearing Board to be entered and considered as evidence regarding this matter.

3. The Parties agree on the [Proposed] Findings and Decision and Order, which include
proposed conditions, and which are filed concurrently herewith.

4. The District does not oppose the Petitioner’s request to grant a regular variance as described

1 in the [Proposed] Order for the Facility.


2 5. The Parties request that the Hearing Board decide this matter based upon this Stipulation, the

4 Parties.

5 6. Neither Party expects the granting of the regular variance requested by Petitioner in this
6 matter, to result in a violation of California Health and Safety Code section 41700 (nuisance).


