Re: Supplement to Petition for Short Variance, Case No. 4935-21

Dear Madam Clerk:

On July 16, 2024, I filed a Petition for a Short Variance, Case No. 4935-21 (the "Petition"), on behalf of Universal City Studios LLC ("Universal Studios"). I am submitting this supplement to clarify and correct some information in the Petition.

In Section 14 of the Petition, in the second paragraph, I wish to correct and clarify some figures. While the beginning and ending dates of August 13 and November 4 are correct, the number of days where theatrical fog will be used between those dates is 69, not 63. (The total number of days between August 13 and November 4 is 84 days, consistent with the request for a Short Variance.) Additionally, to clarify two other figures in that paragraph: For the rehearsal, test, and employee preview events, there are 15 specific events (not 20 events), which may span a total of 20 days, because events begin in the evening and go past midnight into a second day. And there will be 41 public events, spanning a total of 49 days (not 43 public events as the Petition states; I regret the error). To better illustrate the individual events and the affected days, I have attached here the schedule which identifies the number of individual events, as well as the number of days where theatrical fog will be used. Universal intends to submit a declaration that further touches on this schedule, as well.

Additionally, while revising the dates in Section 14, I inadvertently omitted the request that Universal has made for the past several years – and would like to make again this year - to include the flexibility to schedule up to three additional event nights during the timeframe of August 13 through November 4, 2023. Universal Studios will notify the District immediately if a decision to add any of the additional event nights is made.

Finally, I submit this update to the Petition: On July 23, I spoke to Dr. Sarah Reese, Deputy Executive Officer in the District's Planning, Rule Development and Implementation Division. I had previously reached out to Dr. Rees regarding any potential future rulemaking on Rule 401 but had not heard back by the time the Petition was filed. She confirmed in our conversation on July 23 that, as in previous years, the District currently has no plans to amend Rule 401 to provide exceptions for theatrical fog.
