*This document constitutes the Final Environmental Impact Report (EIR) for the ConocoPhillips Los Angeles Refinery PM10 and NOx Reduction Projects. The Draft EIR was circulated for a 45-day public review and comment period on April 4, 2007. The comment period ended on May 18, 2007. Four comment letters were received during the public comment period on the Draft EIR. The comment letters and responses are included in Appendix E of this document. The comments were evaluated and minor modifications have been made to the Draft EIR such that it is now a Final EIR. None of the modifications alter any conclusions reached in the Draft EIR, nor provide new information of substantial importance relative to the draft document that would require re-circulation of the Draft EIR pursuant to CEQA Guidelines §15088.5. Therefore, this document is now a Final EIR. Additions to the text of the EIR are denoted using italics. Text that has been eliminated is shown using ~~strike outs~~.*
