21 Respondent Exide Technologies (“Exide”) files this Status Report in accordance with the
22 Order for Abatement issued in Case No. 3151-32. This Status Report covers the period from
23 October 16, 2015 to November 13, 2015 (“Update Period”), summarizing the work performed
24 during this Update Period.

1 Exide performed maintenance and other tasks utilizing mitigation measures under the Dust
2 Mitigation Plan during this Update Period, including soil sampling as part of the facility
3 investigation process.

5 Tetra Tech is the District’s third-party monitor. Exide received copies of three of the four
6 Tetra Tech weekly reports submitted during this Update Period related to dust mitigation measures
7 for the tasks described above. In each of the three reports, Tetra Tech confirmed that “mitigation
8 measures were observed to be implemented in full compliance with the previously approved
9 mitigation measures under the [Dust Mitigation Plan]. . . .”
