

SCAQMD Tree Planting Partnership

At its June meeting, the SCAQMD Governing Board approved the Tree Planting Partnership which will assist cities and counties with additional tree planting projects.

"Trees have the ability to capture pollutants from the air while adding beauty to our communities," said William A. Burke, Ed.D., SCAQMD's Board Chairman. "This is an opportunity for us to partner with communities to help clean our air and beautify our neighborhoods at the same time."

By partnering with cities and counties, the Tree Partnership, one of SCAQMD's "Helping Hand" Initiatives, aims to create healthy urban forests that will assist in reducing greenhouse gases and other pollutants. The Tree Partnership is open to cities and counties throughout the four-county area served by SCAQMD: Los Angeles, Orange, Riverside and San

Bernardino. One important goal of the Tree Planting Partnership is to provide employment opportunities for students. Another objective is to provide educational outreach for the surrounding communities.

Requirements for tree planting projects include the following criteria:

- Trees should have low biogenic volatile organic compound (VOC) emissions and be native to California;
- Trees should be appropriate for the area where they will be planted;
- Trees will be planted on public lands;
- Tree maintenance must be provided after planting; and
- Outreach and educational components must be provided.

SCAQMD has developed a list of 52 preferred California native trees that have low biogenic VOC emissions, 11 of which are also

drought-tolerant.

A total of \$1.5 million of match funding is available from SCAQMD for this program.

The program opened for applications on June 5, 2009 and will close on July 31, 2009. A voluntary applicant workshop is scheduled for July 17 at SCAQMD's headquarters in Diamond Bar.

2009 "Mow Down Air Pollution" Program Reaches Important Milestone

The "Mow Down Air Pollution" program has placed in service more than 25,000 electric mowers. This milestone was reached midway through this year's program, which is the seventh year in the program's existence. SCAQMD had scrapped highly polluting gasoline mowers, and replaced them with clean electric models, removing about 57 tons of smog-forming volatile organic compound emissions from the Southland's air by the end of June.

Due to overwhelming public response, all 4,000 lawnmowers in the 2009 "Mow Down Air Pollution" program were reserved within the first three days. The 4,000 mowers distributed in 2009 are a large jump from the 500 mowers exchanged in 2003, the program's first year. So, for 2010, SCAQMD has requested matching funds under the California Air Resources Board Air Quality Investment Program to substantially increase the number of mowers that could be exchanged.

California Air Quality Almanac Shows Dramatic Improvement in Air Quality Over Past Two Decades

In May, the California Air Resources Board (CARB) released its annual California Almanac of Emissions and Air Quality. The report showed dramatic improvement in air quality over the past 20 years in Southern California despite increased population and goods movement activities.

The report indicated that ozone levels have decreased approximately 35 percent in the South Coast Air Basin since 1990. Fine particulate matter has decreased nearly 35 percent from 1999 to 2007.

The statewide almanac also reported that over the last 20 years:

- There has been a 53 percent decrease in hydrocarbons and 35 percent decrease in nitrogen oxides (NOx) emissions that contribute to the formation of ozone and particulate matter (PM).
- The number of unhealthy days with high concentrations of ozone has decreased an average of 35 percent.
- Exposure to ozone in major urban areas has dropped approximately 80 percent.
- A number of areas in the state that previously violated the federal 1-hour ozone standard now meet the standard.
- All areas of California now meet state and national standards for nitrogen oxides, carbon monoxide and sulfur dioxide.

These air pollution reductions are a result of regulations adopted over the last 40 years by SCAQMD and CARB. The recent adoption of tougher particulate matter and NOx regulations for trucks and buses, and equipment enhancements at gas stations are expected to help the state meet more stringent air quality standards.

CARB's California Almanac of Emissions and Air Quality is produced annually and contains information about historical, current and forecasted emissions trends as well as historic air quality data.

DID YOU KNOW?

Formaldehyde is produced on a large scale worldwide. One major use includes the production of wood binding adhesives and resins. Many products, including some types of plywood and particleboard, emit significant amounts of formaldehyde or other gaseous pollutants.

The International Agency for Research on Cancer (IARC) reclassified formaldehyde from "probably carcinogenic to humans" to "carcinogenic to humans" in 2004, based on the increased risk of nasopharyngeal cancer. Formaldehyde was also designated as a toxic air contaminant (TAC) in California in 1992 with no safe level of exposure.

State law tasks the California Air Resources Board (CARB) with taking action to reduce human exposure to all TACs. CARB recently approved an airborne toxic control measure to reduce emissions from composite wood products, including hardwood, plywood, particleboard and medium-density fiberboard. Consumers can further reduce their exposure by requesting that new furniture be aired out by the manufacturer or distributor prior to delivery. Another option would be to air out the items in the garage or outdoors before bringing them inside.

Federal Stimulus Funds May Provide Local Air Quality Benefits

In an effort to maximize the use of federal stimulus funds (also known as the American Recovery and Reinvestment Act of 2009 or ARRA) to accelerate its clean air efforts, SCAQMD has been working closely with the region's stakeholders. This effort has included serving as a resource for information regarding funding opportunities, and identifying shelf-ready or shovel-ready projects that will lead to air quality benefits and spur economic growth. SCAQMD identified several areas related to energy and the environment in the \$787 billion ARRA bill for which stakeholders in the region can apply for funding assistance.

SCAQMD has submitted ARRA funding proposals for the replacement of older diesel vehicles that operate out of the Ports of Los Angeles and Long Beach, modernization of off-road diesel equipment, and replacement of older diesel school buses. In addition, SCAQMD applied for ARRA funds to retrofit diesel vehicles with emerging control technologies that significantly reduce nitrogen oxides (NOx) and fine particulate emissions.

More recently, SCAQMD has been working with the region's Clean Cities Coalitions in applying for ARRA funds for alternative fueled vehicles and refueling infrastructure to significantly reduce diesel emissions and the region's use of conventional petroleum fuels.

M. Michael Glovsky, M.D. and Julie Masters have been appointed to the medical member and attorney member positions, respectively, on the SCAQMD Hearing Board. Edward Camarena has been re-appointed to the engineer position.

Mr. Camarena, the current Chair of the Hearing Board, has served on the Board since 1994. Mr. Camarena also serves on the SCAQMD's Budget Advisory Committee. Prior to his service on the Hearing Board, he was Deputy Executive Officer of Operations for SCAQMD for many years where his responsibilities included permitting, enforcement, technical services, information systems, technology development and human resource programs. He holds a B.A. in Chemistry from Occidental College, Los Angeles and a Master of Science in Environmental

Engineering from the University of California, Irvine.

The Board's new medical member is Dr. Glovsky, a Board Certified allergy and immunology physician at the Asthma and Allergy Center in Pasadena. He is also a Clinical Professor of Medicine at USC Medical School and is part of the Internal Medicine training program at Huntington Memorial Hospital, and a Visiting Associate in Chemistry at CalTech. He received his medical degree from Tufts University in Boston.

Dr. Glovsky has authored numerous publications in refereed journals in asthma, immunology, and air pollution. He is a member of many local, national, and international societies of allergy, immunology, and lung diseases.

Ms. Masters, who was named to fill the Board's attorney position, was a Board Consultant to SCAQMD Governing Board Member Joseph Lyou. She also served previously as a Senior Attorney and the Director of the Southern California Clean

Air Program of the Natural Resources Defense Council (NRDC). Ms. Masters left her position with the NRDC in 2006 to become a full-time mother. Ms. Masters holds a B.S. in Accounting from the State University of New York at Albany and received her Juris Doctorate from the New York University School of Law.

The Hearing Board is a quasi-judicial panel authorized to provide relief from AQMD regulations under certain circumstances. As state law requires, Hearing Board members are appointed by, but act independently of, the SCAQMD Governing Board.

Rule Adopted to Address Liquefied Natural Gas Concerns

At its June meeting, the SCAQMD Governing Board adopted Rule 433, Natural Gas Quality, to address concerns about planned additions of imported liquefied natural gas (LNG) to the natural gas supply system in Southern California. Imported LNG generally has a higher heating value than traditional supplies and may adversely impact nitrogen oxides (NOx) and other criteria pollutant emissions from natural gas-fired equipment such as water heaters, ovens, stoves, boilers and furnaces used in homes, commercial buildings and manufacturing facilities. Another anticipated source of natural gas with higher Btu is natural gas transported from the Rocky Mountains, which is becoming a larger factor in Southern California's gas supplies.

Rule 433, which primarily affects the Southern California Gas Company, requires the utility to begin reporting the quality and quantities of natural gas received into its gas distribution system as well as changes to gas quality in the SCAQMD region—data that the utility already collects. The rule also requires the utility to report on a planned LNG Rollout Plan that includes customer education, equipment testing, and mitigation measures, as well as to maintain an annually updated estimate of the emission impacts from higher-Btu natural gas. The new rule provides a structure for SCAQMD and the utility to work cooperatively toward a goal of zero emissions impact from the anticipated influx of higher-Btu natural gas.

The following proposed and amended rules and regulations are tentatively scheduled to be heard at upcoming Governing Board meetings. Rule 102 - Definition of Terms

Amendments to Rule 102 to exempt methyl formate from the VOC definition. Methyl formate has negligible photochemical reactivity and has already been granted VOC exempt status by U.S. EPA.
